



## 2018 TRIBUTE TO WOMEN Honoree Nomination Guidelines

The Women's Center for Advancement (WCA) will honor up to ten women at the 31<sup>st</sup> annual Tribute to Women luncheon on June 12<sup>th</sup>, 2018 at the Marriott on Capitol.

The purpose of this award is to pay tribute to women in our community whose actions have helped others *stay safe and grow strong*.

Each nominee must be an area resident who works and/or volunteers in the Greater Omaha Metro Area. Nominees will be chosen by a selection committee made up of community members who will use the following criteria in their selection process:

- 1) The nominee's achievement and impact on the Great Omaha Metropolitan Area
- 2) The nominee's involvement in community activities
- 3) The nominee's demonstrated commitment to the WCA's mission of empowering women to lead self-determined lives

A separate nomination form must be completed for each nominee. The form may be copied for additional nominations.
